#### Legacy

The St. Cloud Times first wrote an article mentioning the band as early as 1887, and it is believed the band had existed at least a few years before then. Prior to the turn of the century, they were the only band in the nation that played while riding bicycles.

In 1895, the bicycle band was featured at the Minnesota State Fair. In 1923, G. Oliver Riggs, St. Cloud's "Music Man," was invited to build a new boys band in the city. By 1928, his band was composed of 233 members and was billed as the largest band in the world. In 1931 at the National Jaycee Convention in Des Moines, Iowa, the band captured the title of National Junior Chamber of Commerce Band. In 1934, the band ranked first at the American Legion Convention in Duluth. Alumni of the band continued as members of the U S Navy Band, big bands of Tommy Dorsey and Gene Krupa, the Washington Redskins Football Band, and many other military and professional groups. In 1947 the band met weekly with rehearsals and concerts year-round.

In the 1950s the band expanded the repertoire, playing more classical works, Broadway scores, American folk music, and pops arrangements. By 1952 Roger Barrett, later chairman of the St. Cloud State Music Department and a well-known composer, became the conductor of the band. In 1964 the band was the first to perform in the Benedicta Arts Center at the College of St. Benedict in St. Joseph. In 1984 the band played not only at the retirement dinner of Roger Barrett, but also at the dedication ceremonies for the new Heritage Center of the Stearns County Historical Society. Kathleen Johnson became the first woman conductor in the band's history in 1996.

Other directors of the band include Eugene Neri, Marv Peterson, Frank Herring, Richard Hansen, Bob Wig, Lowell Larson, David Haedt, Mel Hauck, Gordon Schlichting, Glenn Tuomaala and Adam Tervola-Hultberg.

In 1999, to celebrate 20 years of normalized relations between the United States and China, the St. Cloud Municipal Band was invited to perform in Beijing. While in China the musicians also had the opportunity to visit The Forbidden City, The Great Wall, The Great Hall of People, The Temple of Heaven, and Tiananmen Square. In February of 2005 the band traveled to Puerto Vallarta with David Haedt conducting. In the fall of 2005 the band performed at the deployment ceremony of the Minnesota National Guard to Iraq.

In June 2010, April 2014 and June 2018, Spalt, Germany, St. Cloud's Sister City, invited the St. Cloud Municipal Band to help celebrate the 1200th year of Spalt's existence and the 150th year of their brewery, the largest industry of the city of Spalt.

The band is currently conducted by Dr. Catharine Bushman, a professor at St. Cloud State University, and can be heard in Barden Park near the St. Cloud State University campus in the summer. The band also performs at special events such as the Memorial Day program at the VA Medical Center, the Fourth of July Fireworks at Hester Park and Whitney Senior Center for a Christmas concert in addition to Fall and Spring concerts at the Paramount Theatre. The band also performs in area schools and nursing homes to further promote life-long enjoyment of music making.

#### 2020 events

The Covid-19 pandemic severely limited the band's 2020 plans.

The band performed at three nursing homes in January and February before the pandemic spread in the community.

In late March, the band paused all rehearsals and performance plans. The band rehearses at St. Cloud's Tech High School and the school district shut down the schools to community groups.

The band's spring concert planned for the Paramount Theater was canceled when the theater closed for all events.

As the public health emergency unfolded, the band's planned events for the summer and fall were canceled. Those events included the Memorial Day program at the St. Cloud Veterans Affairs Medical Center, the city's Fourth of July Fireworks and weekly concerts at Barden Park.

As the public health crisis continued, the band also canceled its fall concert at the Paramount Theater and a Christmas Concert at the Whitney Center.

During the pause, the board of directors continued with monthly meetings via Zoom. The band also conducted several Zoom events for all members to foster communication and engagement during the shutdown.

As some health restrictions eased, the band planned several events so that band members could play while maintaining appropriated public health practices. We called these events Park and Play. Musicians gathered in St. Cloud's Wilson Park, with plenty of space between people. These events were not intended as performances but instead opportunities for musicians to play as a group.



The pause affected our finances. While some expenses dropped because, for example, we did not have to pay for rehearsal space, the cancellations of our only two paid concerts also resulted in a considerable loss of revenue.

Early in 2020, the band applied for and received a \$2,000 grant from the Central Minnesota Arts Board to buy a sound system. The band frequently performs at venues without any sound equipment. The new equipment allows the audience to better hear the director and soloists.

Before the shutdown, the board was working with Stearns History Museum to prepare a display on the band's history and perform a concert for museum members. This plans are on hold until the museum resumes programming.

#### GRANT AWARDS – Central Minnesota Arts Board (CMAB)



Many thanks to the Central Minnesota Arts Board for two grant awards during 2017. An arts support award of \$3,384 was awarded, with proceeds to go towards the general operating budget of the band. A Capital Arts award of \$2,986 was awarded for a new set of Timpani Drums.



#### LOCATIONS AND POPULATIONS SERVED

The band meets at various schools in the St. Cloud Area for practice. The concerts serve the greater county region of Central Minnesota.
